- 3. **Approval of Minutes** from August 2023 Heidi Would (ACTION ITEM) Calloway motioned to approve, second by Menzel, all in favor (6-0), no abstentions

4. Treasurer's Report – Dimitri Menzel (ACTION ITEM)

Thank you to Karen and Ron for assistance with the Saba Foundation for the Grant writing and presentation as they approved funding (see those details in the email)

- a. Expenses to date:
 - Junk Hauler voted in email to pay \$256 +/-
 - Plamann dump fees waived.
- b. Open House raised \$5,291 in donations.
- c. All donors get receipts with taxpayer ID for tax purposes.
- d. An auditor needs to be secured. The CPA has been identified by Miller.
- e. Motion presented to approve \$45/90 via Quickbooks and to further investigate Tech Soup to work through this way first at \$75 year once Menzel will explore the limitations of this software and report in October meeting.

Motion to approve by Would, second by Calloway, all in favor (6-0)

On a motion by Calloway, second by Roni, the treasurer report presented as of September 12, 2023 was approved. The motion carried on a voice vote. (6-0)

5. President's Report – Brad Sherwood

6. Board member reports - All

- a. Calloway reported Saba Foundation received donation (\$290,885.00), they originally asked for a board position from their organization and then rescinded, instead they would appreciate recognition or naming the playground structure with the "Saba" name.
- Please refer to the email sent earlier et al.
 "I'm delighted to inform you that the board of directors voted to support the Mark West

Area Community Fund's project. Our office will prepare a grant award letter, but in essence, the grant will provide by the October deadline \$72,505 to acquire the land and \$3,380 in operating costs. Once the land has been acquired, the Saba Foundation will issue a second payment of \$215,000 to develop the playground, which the board of directors would like to be named the Saba Foundation. This second payment will be issued in 2024. The board of directors further request that a bench be installed in the playground area with a plaque that further pays tribute to the Saba Foundation.

The board of directors discussed further Lewis Warren's suggestion that one of the directors from the Saba Foundation join your organization's board, but upon further reflection, this may not be necessary. The board of directors of the Saba Foundation are committed to making this playground a reality and we suspect will provide support for maintenance once the playground has been built."

 - Board of Directors Insurance: Motion via email was approved to pay \$653 for board of directors' liability insurance. Brad Sherwood paid the premium (\$653); to be reimbursed by the Fund once we receive checks from bank.
 - ii. Miller identified Jeff Dryer CPA from Sonoma will handle non-profits \$390 per hour they estimated a "few hours". Looking for the filing and audit piece. The fiscal year is calendar year so we have until March 15 to do taxes but close and finalize books by December including a budget presentation. Checking with other local non-profits. Propose Self file the taxes and then have an auditor 3rd party to review documents. Waiting for further report from Miller.
